### PARENTAL AUTHORIZATION

I, parent or guardian of the above-named candidate for a position in above mentioned baseball program, hereby gives approval to his/her participation in the Metropolitan Junior Baseball League. I acknowledge and represent that I understand the nature of what is involved in participating and playing the game of baseball and all it entails. I further acknowledge that my child is qualified, in good health, and in proper physical condition to participate in all aspects of this activity. I fully understand that baseball and all activities associated with the program involve certain risks and potential harm of serious bodily injury, including but not limited to permanent disability, paralysis, and death. I acknowledge my understanding that these risks and potential dangers may be caused by my child's own actions or inactions, the actions or inactions of others involved and/or participating in the program or activity, or the condition in which the activity or game is taking place. In consideration of these factors, I hereby release, discharge, covenant not to sue, and I further agree to indemnify and hold harmless all parties identified as "Releasees" including, local league organization, the organizers, sponsors, supervisors, participants and/or other parents from all liability, claims, demands, losses, costs, and/or damages incurred as such caused by my child or as alleged to be caused in whole or in part by the Releasees or otherwise except as herein provided. I further agree and acknowledge that if despite this release, I or anyone on my child's behalf makes a claim against any of the Releasees, I will indemnify, save and hold harmless each Releasee from any litigation, expenses, attorney fees, loss liability, damage, or other cost which may occur as the result of any such claim, to the fullest extent permitted by law. Notwithstanding the covenant not to sue and to indemnify and hold harmless the Releasees shall not be valid or enforceable if such liability, claims, demands, losses, costs, and/or damages is alleged to be caused in whole or in part by the negligence of said Releasees. I assume all risks and hazards incidental to such exposure and participation to other ancillary activities including transportation to and from the activities; and I hereby waive, release, absolve, indemnify and agree to hold harmless said Releasees, including, parents or local league organization, the organizers, sponsors, supervisors, participants and persons transporting the player to and from activities, for any claim arising out of an injury to the player, except to the extent and in the amount covered by accident and/or liability insurance held by the local league. I also grant permission to managing personnel or other league representatives to authorize and obtain medical care from any licensed physician, hospital or medical clinic should the player become ill or injured while participating in league activities away from home, or at other times when neither parent, nor guardian is available to grant authorization for emergency treatment. I agree that all still images, video and live feeds of my child shall remain the property of event organizers.
